4. WHILE BURNING, PERMITEE MUST BE PRESENT AT ALL TIMES, AND ENSURE THAT THE FIRE IS UNDER CONTROL.
5. PERMIT MAY BE REVOKED DUE TO WEATHER CONDITIONS.
6. PERMITEE MUST NOTIFY POCONO TOWNSHIP PRIOR TO BURNING AT (570)629-1922 OR E-MAIL AT [dackerman@poconopa.gov](mailto:dackerman@poconopa.gov)
